



Member Survey - December 2025

The Countryside Management Association (CMA) is in the process of preparing a bid to the National Lottery Heritage Fund (NLHF).

If successful, it would allow the CMA to contract a full time Development Officer and a part time Communications Officer for two years.



Development Officer (not an exhaustive list):

- prepare a 5/10 year business plan for the CMA, including financial planning and fundraising
- collate data on the countryside/greenspace sector eg. numbers employed, job roles
- develop policies/Position Statements on the many vital issues within the industry to assist in advocacy work and responses to consultations
- increase membership numbers; review member categories and benefits
- review the governance structure of the CMA including the regions
- develop targeted training options for members
- increase collaboration/partnership working with employers and like-minded sector organisations (CIEEM, IPRoW etc)



Communications Officer (not an exhaustive list):

- prepare and implement a Communications Strategy
- ensure the CMA has a much improved profile nationally
- review web site, social media, publications, events
- alongside the Development Officer, increase promotion of the accreditation offer

The CMA Board has high ambitions for the future of the CMA however the volunteer nature of Board roles means the capacity to undertake much of the required work is limited.

The CMA has every intention of changing that, but we need your help by completing this survey.



The National Lottery Heritage Fund has several criteria that have to be met in any bid for funding. Critically, it needs to know:

- which natural, historic and cultural heritage assets members currently look after
- that this heritage will be better conserved, protected and enhanced, if the bid is successful
- the level of engagement with visitors, groups, schools, volunteers etc
- the CMA membership profile - job titles and roles
- how improved benefits for members eg. training, networking, exchange of best practice, will actually benefit heritage.
